# EU Health Workforce Network Update 6th edition

#### Latest news from the "EU Health Workforce Network Update"



Celebrating the second year anniversary of SEPEN

SEPEN is celebrating its second anniversary and would like to thank all the experts for the active contribution in the network. SEPEN Expert Network is still growing, now comprises more than 300 experts from various countries, backgrounds, priorities and expertise.

Anniversaries always find us taking stock...

If we look back, many activities have been carried out throughout the year. Consider the events: four webinars on the EU Health Policy Platform and two workshops in Budapest were organized in various topics relating to health workforce planning, e.g. data, interprofessional education and health workforce mobility. Each event attracted approximately 40-45 experts to discuss these challenging topics and to exchange expertise and best practices. International findings and developments summarized by WHO, OECD, EPSU-HOSPEEM; national level case studies from Belgium, the Netherlands, Italy and Hungary; HWF research results from Poland and Ireland, and even personal testimonials of migrant health workers contributed to better understanding of different aspects of the complex HWF planning environment. In conclusion, we can state that each country has its own issues concerning health workforce, e.g. determining the ideal coverage, intake and attrition in education, national and international training capacities, ageing workforces, unequal distribution,

available capacity and vacancy, recruitment and retention, integrating foreign workforce, building central data warehouse to monitor and collect evidence on HWF, but the facilitated information exchange and knowledge sharing bring cumulative experience together, and help health systems in the EU to operate more effectively.

Our recent evaluation survey results show that health workforce mobility is still among the top interest of SEPEN experts, along with further topics of health policy and the emerging skills of health professionals. Additionally, it is important to note that the majority of the participating experts demonstrated in the survey that knowledge is improving and contacts are expanding due to different SEPEN activities. We were grateful to hear that most of you felt that you can contribute to the activities, particularly in the ongoing phase of country level information update. SEPEN is carrying out a mapping exercise that collects evidence for an overview of health workforce planning systems in all EU Member States. Some experts have already been contacted to support this activity with information validation, but we still need your engagement and contribution to finalize this updated information repository. In terms of tailored advice and guidance through exchange of expertise of the joint tender, SEPEN received some interest from Member States for advice on the implementation of HWF planning. We do count on you in expressing your interest for exchange of expertise in the form of workshops, peer reviews and training/coaching.

...and forecasting the upcoming year.

Looking forward, there are more events to come: for this calendar year two webinars are already planned for autumn and winter. The topic of the first event will be health workforce planning in international politics, while the latter webinar will focus on digital transformation of healthcare and its influence on HWF.

As to workshops, the next one will be organized in Belgium in November 2019. It will discuss a topic that has rarely been debated before, namely, the aspect of quality of care, patient safety and working conditions in HWF planning and preparations are ongoing for all these events, so keep an eye on our announcements. For 2020 more activities, more webinars and one more workshop are planned, which will continuously provide us the opportunity for further exchange.

Furthermore, let us briefly summarize some international events, at which SEPEN took part in 2019. These include the Health Professionals Crossing Borders conference in Dublin, the European Health Professionals Competent Authorities (EurHeCA) Workshop in Brussels, the International Network for Health Workforce Education (INHWE) conference in Nicosia, the European Federation of Employees in Public Services (EUROFEDOP) Seminar in Podgorica, the EHMA Annual Congress in Espoo, the Peer learning event on brain flow in Europe workshop in Brussels, the Human Resources Management and Performance Appraisal in the Health Sector, CEFPAS in Sicily, the Conference on The future of health - Advancing the UN 2030 Sustainable Development Agenda in Europe, (PACT) in Brussels, and the Health Workforce Planning and Forecasting ALTEMS (School of Economics and Management of Health Systems) in Rome.

Not lastly, SEPEN was selected to be part of CHAFEA Success Stories at the <u>EU Health Programme High Level Conference</u> in Brussels on 30th September 2019. The event was hosted by Vytenis Andriukaitis, European Commissioner for Health, and organised by the Consumers, Health, Agriculture and Food Executive Agency (CHAFEA) with support by the European Commission Directorate-General for Health and Food Safety. #### Watch our last webinar and join the next one

On 5 July 2019, SEPEN joint tender organized its fifth webinar for the expert network.

This time, the webinar referred to the workshop on health workforce mobility that took place earlier this year. The purpose was to revisit some of the main outcomes, receive an update on what has happened so far and see how SEPEN is supporting the health workforce mobility agenda.

The first keynote speaker of the webinar, Mr Ibadat Dhillon from the Department of Health Workforce at the World Health Organisation (WHO) presented an overview of some of the trends in relation to international health workforce mobility, the work undergoing at WHO and an update on the WHO Global Code of Practice on the International Recruitment of Health Personnel.

Dr. Eszter Kovacs from Semmelweis University elaborated on how the SEPEN expert network addresses health workforce mobility issues. Key information, main messages and findings from SEPEN activities were summarized to highlight the importance of improving quantitative and qualitative data collections, developing more precise measurement tools, strengthening policies and collaboration in managing HWF mobility in the EU, considering patient and student mobility and their implications to HWF composition.

Mr. Paolo Michelutti from the Italian National Agency for Regional Healthcare Services (AGENAS) illustrated how the SEPEN tender can support Member States in their mobility-related policy agendas. He presented how to request and receive tailored advice and guidance from SEPEN and how to benefit from the expertise SEPEN Expert Network can offer.

# Managing health workforce mobility in Hungary - Policy measures to retain health professionals

Health workforce (HWF) mobility - moving within the European Union - and migration - moving in and out of the European Union - are considered as global phenomena. Crossing borders in the European Union (EU) is even better facilitated, as the knowledge and skills are harmonized within the EU by the Directive on mutual recognition of qualifications (2005/36/EC) in the sectoral health professions, and therefore could be easily mobilised. The member states of the EU often face significant inflows and outflows of health professionals on a system level, as mobility is fostered within the EU internal market.

Some countries can be identified as sending countries that experience high outflows and shortage of health professionals (e.g., Romania or Bulgaria), and some as recipient countries that highly rely on foreign health workers (e.g., the UK, Germany, or the Scandinavian countries). The main trends in HWF mobility are the following: from East to West, from South to North, and cross-border movements are very frequent, particularly in countries with high proximity e.g., Benelux countries.
