Work packages update

Health Workforce Planning and Forecasting Expert Network

On the 18th of March 2020 SEPEN joint tender organised its 8th webinar focusing on "Brexit and its impact on health workforce planning".

Taking into consideration that Brexit will potentially disrupt the mobility patterns of health professionals, students and researchers and will impact health workforce planning both within the United Kingdom and the EU Member States, this event was seeking to explore the problem from a political, system-level and professional point of view.

The SEPEN webinar presented examples of mobility, the perspective of professionals, and the implications for the health system in term of workforce planning. These insights were provided in an interview with **Professor Raymond Galea** as Head of the Maltese Postgraduate Medical Training Program, **Mr Paul Laffin**, who is EU Public Affairs Manager at the British Medical Association, and **Ms Kate Ling**, the Senior European Policy Manager at the NHS European Office for the NHS Confederation.

Mapping HWF planning and policies in the European Union

The mapping exercise has been finished.

SEPEN has finalised the mapping study and the country profiles of each EU Member States will provide an overview of the main characteristics and a detailed description of the HWF planning systems and policies. These specific country profiles also include appendixes offering several details about HWF information on countries and lists of national level policies and actions.

Merging country information into an e-book will enable experts to access up-todate country profiles of the EU and a HWF planning and policy respository platform will be available soon.

Workshops update

The fifth "Digital health" SEPEN Workshop goes digital.

As announced earlier, the fifth workshop of SEPEN - which was aimed to be organised in Rome -, was postponed due to the exceptional circumstances and travel restrictions of COVID-19.

Our team was working to find the best solution in order to organise this important SEPEN event, in which many professionals already showed remarkable interest. Hereby, we are glad to inform you that SEPEN's fifth workshop goes digital.

The workshop will be held online in three separate sessions, on three different dates, but the main focus still addresses the same topic, namely:

"Digital health: what are the implications for supply, demand, monitoring and organisation of health workforce?"

The events will deal with the impact of the development of digital technologies and information technology on the current and future health workforce. Through an interactive format, it will particularly focus on the implications of digital health on the "barriers to" and "strategies for" improving the availability, acceptability and quality of the health workforce and what health workforce planners need to do to incorporate those implications in their models.

The workshop sessions will present the emerging trends in the development and digital transformation of the health workforce, discuss the main challenges that digitalisation poses upon health workforce planning, and propose solutions to the issues discussed.

Too little, too late. Underinvestment in public health capacity is a false economy

It was always a question of when and not if. It has been clear for decades that a virus that had jumped from animals to humans would spread rapidly throughout the world. There have been many warnings, including swine and avian influenza and, in the early years of the 21st century, SARS. Yet in many countries, these warnings went unheeded. This was especially so as memories of the 1918 flu and, more recently, the scourges of smallpox and polio faded, even if the last of these has yet to be eradicated. The challenges were there for all to see. Some countries undertook exercises in which they tested their response systems but although they find them wanting, many did little to fix them. There were always more pressing short-term problems. In some countries, such as the USA, strong systems that had been in place were dismantled, sacrificing the safety of the population for a dystopian ideology. Suddenly, as COVID-19 spread across the world, the effects of this disinvestment became all too clear. While a few governments, and especially those in Southeast Asia that had recent memories of dealing with SARS, were able to respond quickly and effectively, limiting the spread of disease and resulting deaths, others were floundering. Confronted with the grim reality that they had squandered the assets they had inherited from previous generations, they struggled to develop responses with the limited capacity that was available.

COVID-19 and the medical workforce: European doctors report Sarada Das Standing Committee of European Doctors - CPME

The COVID-19 pandemic has made health and the health workforce headline news. Within a matter of weeks, the availability, distribution and working conditions of health professionals have gained their deserved recognition in the general public as vital questions which have direct effect on public health and security.

In a survey coordinated by the Standing Committee of European Doctors

(CPME), national medical associations are reporting doctors' experience of the COVID-19 pandemic. The information collected underlines how much high-quality patient care is dependent on the organisation of care, effective health workforce planning and safe working conditions.

One obvious challenge is the availability of medical workforce. The pandemic has made existing shortages more acute in many countries, such as Bulgaria and Ireland. Others report that is only thanks to relatively low infection numbers that the workforce is able to deal with the pandemic, but the general shortage of doctors continues to affect patient care beyond COVID-19.
